### Regional Action Proposals:

#### Education:

- ❖ Fracking & importance of organic gardens
- ❖ Water issues on Long island
- ❖ Regular feedback regarding our investments (TRI-CRI & ICCR) – what progress have we made?
- ❖ Booklet available through Presentation Parish, Upper Saddle River, NJ – excellent resource
- ❖ Speakers on national issues to raise our awareness & help position ourselves to make commitments/stances
- ❖ Share the DVD far and wide : schools; parishes; senior citizens; other women’s congregations and the men religious who work with us; sponsored works; co-workers; local TV Channels , Religious networks, & major networks (Channel 12; Telecare; EWTN; PBS; Bill Moyers; 60 Minutes)

#### Internal Policy:

- ❖ Evaluate how we come together – greater use of technology
- ❖ Establish Earth-friendly policies for meetings / vehicles / purchasing
- ❖ Increase use of hybrids; shared auto travel
- ❖ Encourage “zero waste initiatives” in Motherhouses, sponsored works – use only biodegradable/compostable cups, plates, napkins; no plastics
- ❖ Bring own mugs/water bottles to congregational meetings
- ❖ Set congregational goals to reduce waste & set a time-line for doing so
- ❖ Keep the topic in front of us at all gatherings
- ❖ Create waste-free areas
- ❖ Energy audits at Motherhouses & sponsored works
- ❖ Encourage local communities to be attentive to their carbon footprint
- ❖ Empower our new Justice Promoter to gather and unite us around issues

#### Policy Participation:

- ❖ Does Brookhaven National Lab need an energy audit?
- ❖ Engage in Sandy relief efforts; be part of local Chamber of Commerce; lobby local/state government; attend civic meetings

#### Corporate Advocacy:

- ❖ Establish a Regional Portfolio Advisory Board
- ❖ We need to screen our investments
- ❖ Support the work of TRI-CRI

#### Advocacy on behalf of Earth:

- ❖ Actively support and participate local groups working to mitigate the effects of global climate change.

- ❖ Work with at least one local organization, such as Citizens Campaign for the Environment here on Long Island that is involved in energy, food, water issues

- ❖ Help create and/or administer a process for an energy audit in each congregation, and work with leadership teams to make this happen.

#### Transportation/Meeting:

#### Corporate Advocacy:

- ❖ Stance on fracking
- ❖ Use Simone Campbell's influence to move this topic

#### Advocacy on behalf of Earth:

- ❖ Learn more about the national/international Rights of Earth movement, and Civil Rights for the Earth. Connect with League of Women Voters re: policy, legislation and regulation.
- ❖ Consider windmills on Motherhouse properties

#### Communication:

- ❖ We need to be more aware of the success stories that have been the result of a community decision. Perhaps the office to gather information regarding what we have done, and what still needs to be done.
